#### RATIONALE:

The original motion was submitted to the cancelled 2020 BCSTA AGM and subsequently passed by the October 2020 BCSTA Provincial Council. Both the Ministry of Education and the Ministry of Public Safety and Solicitor General have agreed to the need for the funding; however, progress seems to have stalled. Four years will have passed for the resubmission of this motion to the 2024 BCSTA AGM.

## **BACKGROUND**:

Work toward establishing sustainable and comprehensive funding for the much-needed adult graduation education programs in our correctional facilities began while the system was experiencing and recovering from the COVID pandemic. Then Minister of Education, Jennifer Whiteside, and Minister of Public Safety and Solicitor General, Mike Farnworth, were both in agreement that our most vulnerable and at-risk benefit from participation in education and that experiencing academic success has a significant positive impact on future outcomes. The intrinsic value of supporting adults of all backgrounds in their journey to complete school was recognized.

On March 29, 2022 Minister Farnworth stated that work continued on "the funding model review to examine the funding and resources required to support vulnerable learners with life-altering educational opportunities."

Securing funding to districts for the 2024/25 school year would provide educators with the necessary resources to design effective, sustainable programs and continue encouraging inmate participation.

# Subject: Funding for Programs at Provincial Correctional Centres

At the British Columbia School Trustees Association's 2024 annual general meeting, our members, representing the 60 boards of education in B.C., passed the following resolution:

"That the BCSTA request the Minister of Education and Child Care and the Minister of Public Safety and Solicitor General provide an update on the review of the funding and resources, and next steps in supporting learners in our provincial correctional centres."

The resolution is similar to a previous resolution passed at BCSTA's October 2020 Provincial Council meeting, and we understand that both the Ministry of Education and Child Care and the Ministry of Public Safety and Solicitor General continue to appreciate the need to support learners in correctional centres.

Vulnerable and at-risk groups, including individuals in correctional centres, stand to greatly benefit from education. Unfortunately, the current course-registration funding model is inherently unsuited to the realities of correctional centres where the year-round population changes daily and teachers are additionally dealing with barriers. These challenges include mental health issues, addictions, victims of abuse, learning disabilities, impulse and anger control, residential school experiences, intergenerational trauma and a history of failure in school. This results in a challenging system that is chronically under-resourced.

During the debate of this motion, Maple Ridge-Pitt Meadows Chair Elaine Yamamoto emphasized that "It cannot be expected that funding be taken from operating funds as only nine districts have correctional facilities, but they carry the load for the full province." As part of our recent meetings with the Ministry of Education and Child Care staff to follow up on resolutions stemming from our 2024 AGM, we came to understand that while funding is unfortunately limited, discussions between your ministries have taken place, and strategies are taking shape to address this growing need.



While a response at this time is not required, given the update provided during our recent meetings, we will continue to monitor the situation in the future and advocate for this important need when the opportunity arises as we seek to bring hope for a brighter future for these individuals. Should updates become available, we request that you provide us with information to share with our membership as soon as possible.
