Board Chairperson Report 2023/24

Board Chairperson Yamamoto presented the annual Board Chairperson Report 2023/24 on behalf of the Maple Ridge – Pitt Meadows Board of Education. The full presentation is available on the district website at https://www.sd42.ca/board-of-education.

Board Chairperson and Vice-Chairperson Re-elected

Trustee Elaine Yamamoto was re-elected chairperson of the board and trustee Kim Dumore was re-elected vice-chairperson of the board. Both positions are for a one-year period.

Presentation: Trades Programs

Brad Dingler, the District Partnerships and Trades Programs Coordinator, and Steve Wiebe, the Principal of Alternate Education and Trades and Partnerships, presented to the board on the Skilled Trades Partnership programs in the Maple Ridge – Pitt Meadows School District. The district offers seven programs across ten trades cohorts in partnership with post-secondary institutions. Enrolled students must achieve a minimum average of 70% to receive certification.

For the 2024/25 school year, the Maple Ridge – Pitt Meadows school district ranks second in the province for the highest number of trades training seats, surpassed only by Surrey Schools, which serves a significantly larger student population of 81,000. Current program offerings include Residential Electrician, Hairdressing, Metal Fabrication, Plumbing/Fitting, Automotive Technician, Culinary Arts, and Residential Construction. Board of Education Annual Work Plan

Superintendent's Update

Superintendent Downs spoke to the board about the school district's focus on literacy and its commitment to examining more closely and acting upon the data referenced in the 2023/24 Supporting All Learners report, particularly as it relates to instances where students are not yet meeting expectations.

Policy Updates and Report

The board received for information and continuation of the consultation process updates to the following policies:

- Policy 9510: Flags of Canada and British Columbia
- Policy 9430: Physical Restraint and Seclusion in School Settings
- *Policy 8220: School Day* Proposed for retirement in favour of relying directly on existing legislation in the School Act and district calendars for governance

Trustee Motion
